## **Boards & Committees Engagement Discussion**

Committee discusses inviting Carlos Gutierrez and/or Scott Diffenderfer from the Program for Public Information Committee to attend the next meeting in April.

C McCord asks question regarding website engagement data to use as feedback for future. A Knowles shares that the committee's information has been shared in newsletters as well as in Vulnerability Assessment popup events and this should have helped increase engagement. Will present data during next meeting.

G Treuer suggests asking John Stuart to attend future meeting. A Knowles shares information about one of the classes J Stuart teaches and how this may be an opportunity to learn more about his teachings as well as his capacity with the Chamber of Commerce. C McCord suggests using this as an opportunity to increase engagement and potentially invite J Stuart to attend May or June meeting.

C Dyer suggests inviting FEMA representative but A Knowles shares this may be difficult due to limited availability; A Knowles shares information about the upcoming virtual Flood Insurance Forum (April 8<sup>th</sup> @5:30pm) as well as some of the speakers who will be attending. G Gonzalez to ensure the meeting is publicly noticed.
